## NOTIFICATION

Consequent upon reduction of rate administration charges by the Employees Provident Fund Organisation (EPFO) vide its notification No. WSU/44(2)97/Administration Charges/- 4570 dated 28.05.2018, the Hon'ble Vice-Chancellor, CSKHPKV, Palampur has been pleased to implement the reduced rate of administration charges of EPFO from 0.65% to 0.50% as such in this University w.e.f. 01.06.2018.

Accordingly, the University will have to pay EPF contribution @ 13% on minimum wages w.e.f. 01.06.2018 instead of existing rate of 13.15% on the services to be outsourced.

Therefore, the rates for different categories of outsourced services have been worked out and enclosed as Annexure-I for non-tribal areas and Annexure-II for tribal areas.

It is, therefore enjoined upon all concerned that the rates for each category enclosed may be followed strictly. However since the amounts of sanction(s) already obtained for each category of outsource services are on higher side, therefore revised sanction cases may not be moved.

Other instructions as contained in the notification No. QSD.8-102/DR/CSKHPKV/-2431-2515 dated 26.03.2018 shall remain the same.
