NOTIFICATION

With reference to this Directorate notification No. QSD.8-110(2)/DR/CSKHPKV/-11959-12029 dated 08/03/2019, all concerned are informed that the service contract for Outsource Services with M/s Sampark Services, VPO Gohar District Mandi HP was extended with effect from 01/04/2019 to 30/06/2019 or till the new contract entered into by the university (whichever would occur earlier) and all concerned were requested to obtain the sanction to outsource required manpower from 01/04/2019 to 31/05/2019.

In this context it is informed that since the university could not enter into new contract till date due to imposition of Model Code of Conduct in view of the Lok Sabha General Elections-2019, it is therefore enjoined upon all concerned that the sanction to outsourced required manpower from 01/06/2019 to 30/06/2019 on the existing rates be obtained from the controlling officers of the respective projects/schemes.

Beside above, all concerned are requested to make the payment of arrears of outsourced services on account of enhancement of minimum wages, if any latest by 15/06/2019 failing which the Head of Department concerned shall be responsible for any type of dispute/litigation arising out of the issue of non payment of arrears.


