
Subject: Proceedings of the meeting held under the chairmanship of Director of Research-cum-Principal Employer, Directorate of Research, CSKHPKV, Palampur on 17.07.2021 at 03:00 PM regarding engagement of Outsource manpower through the approved contractor.

Sir/Madam,

This has reference to this Directorate endorsement No. QSD.8-110/ DR /CSKHPKV/3075-3154 dated 26.07.2021, wherein subject cited proceedings of the meeting were circulated to all concerned for necessary action. In the above proceedings, it was clearly mentioned that no Offices / Departments/ Units/ Stations/KVKs will engage Outsource Worker without the prior approval of the Director of Research-cum-Principal Employer. But it has been observed that some of the Offices/ Departments/ Units/Stations/KVKs are still engaging outsource workers at their own level without getting the prior registration with the service providing agency as well as approval of the competent authority. It has also been observed that the Offices/Departments/Units/Stations/KVKs, after one month of engagement of Outsource Workers, approaching and putting pressure to the service providing agency as well as this office for their registration which is beyond the terms and conditions of the tender document/Labour Licence i.e. for 800 workers. This is not a healthy practise and viewed seriously.

It is, therefore, enjoined upon to all concerned that no offices /departments of the University will engage outsource workers at their own level without prior approval of this Directorate failing which the entire responsibility will be rest upon the concerned departments/Offices and necessary action will be initiated against them. If any have some urgent need of manpower, they have to write to this Directorate. After examining/finalising the request of the department concerned, the necessary directions/orders will be issued on the behalf of this Directorate.
