- b. Creation of a separate page at the University website for anti-ragging activities and ensure its regular up-gradation/updating with complete address of the Nodal Officer, Anti Ragging Cell; Chairmen/Convener of Monitoring Cell/Anti-Ragging Committees/squads constituted at the University Level as well as College Level with details of their contact numbers.
- c. Submission of reports to University Grants Commission & ICAR from time to time in consultation with the Registrar, CSKHPKV, Palampur with regard to anti-ragging measures taken by the University;
- d. To report to the Vice-Chancellor about the measures taken by the University at various level to keep the Campus ragging free.
