

This is in reference filling up 15% seats for admission to B.V.Sc & A.H Degree course in recognized Veterinary Colleges (except Jammu and Kashmir) under All India Quota.

In this context, it is informed that in consultation with the Department of Animal Husbandry, Dairying and Fisheries, Ministry of Agriculture and Farmers Welfare, Government of India, it has been decided to use National Eligibility cum Entrance Test (UG)-2019 (NEET(UG)-2019) qualified merit list for admission of students to B.V.Sc & A.H.Degree course during the academic year 2019-20 for filling up of seats in recognized Veterinary Colleges (except Jammu and Kashmir) under 15% All India Quota. The other criteria for admission/selection of students of admission to B.V.Sc & A.H. Degree course shall be as per VCI - Minimum Standards of Veterinary Education-Degree Course (B.V.Sc. & A.H.) Regulations, 2016. The students desirous to take admission into B.V.Sc & A.H. Degree course under 15% seats on all India basis have been advised to appear in NEET (UG)-2019 to be conducted by National Testing Agency on 5th May, 2019.
