**ORDER**

In exercise of the powers conferred on me under Sub Section (1) of Section 12 of the Himachal Pradesh University Act, 1970 (Act No.17 of 1970) as amended upto date I, Kaptan Singh Solanki, Chancellor, Himachal Pradesh University, Shimla in consultation with the State Government of Himachal Pradesh, hereby appoint Dr. Sikander Kumar, Professor & Chairman, Department of Economics, Himachal Pradesh University, Shimla as the Vice Chancellor, Himachal Pradesh University, Shimla for a term of three (3) years from the date he enters upon his office or till the date he attains the age of 65 years, whichever is earlier in the pay scale of Rs. 75000/- fixed. He will be eligible for allowances as admissible to the officers of the highest grade of the Himachal Pradesh Government.

The other terms and conditions of the service applicable to him will be as laid down in Himachal Pradesh University Act, 1970 as amended from time to time.




