Sub Extension in appointment of Prof.(Dr.) Ranbir Singh as Vice-Chancellor, National Law University, Delhi.

The term of appointment of Prof.(Dr.) Ranbir Singh, the Founder Vice-Chancellor of National Law University, Delhi, is coming to an end on 20th July, 2018. The Governing Council, as per provision of Section 20(4) of the National Law University Delhi Act 2007, has extended the term of Prof.(Dr.) Ranbir Singh, Founder Vice-Chancellor upto 23rd September, 2019 when he attains 70 years of age.

Further, in exercise of powers conferred under Section 20(4) of the National Law University Delhi Act, 2007, the Hon'ble Acting Chief Justice Delhi High Court and Chancellor, National Law University, Delhi has directed that Prof.(Dr.) Ranbir Singh may further continue in the office of the Vice-Chancellor for a period upto one year from 23rd September, 2019 or till the date the new Vice-Chancellor assumes office, whichever is earlier.
