

Definition of Single Girl Child:	Single Girl Child means parent having a single girl child without any sibling subject to fulfillment of eligibility criteria as prescribed for State Quota Seats. Under this category, the candidate has to produce a certificate as per Appendix-1 .

The above provision be also deemed to have been incorporated in the University Academic Regulations.


