ORDER

In exercise of powers conferred on me by Sub Section (2) of Section 15 of Sardar Balabh Bhai Patel Cluster University, Mandi, Himachal Pradesh Act, 2018 (Act No.6 of 2018), I, Devvrat, Chancellor, Sardar Balabh Bhai Patel Cluster University, Mandi, Himachal Pradesh in consultation with the State Govt. hereby appoint Dr.C.L.
