

Keeping in view the increasing of COVID-19 positive cases in Himachal Pradesh and recent corona virus positive cases reported in CSIR Complex near by University campus and in order to contain the spread of COVID-19, the Vice-Chancellor has been pleased to order to close gate No.3, presently being kept open during office hours till further orders. The gate leading to Seed Science and Technology department shall be maintained by the Head, Department of Seed Science & Technology, COA, CSKHPKV, Palampur forthwith.

It has also been ordered that entry to the University employees will be regulated through gate No.1. No outsider will be allowed to enter University premises as a safety measure to the students as well as Teaching, Non-Teaching University community and residents. The entry of outsiders from Dr. G.C. Negi College of Veterinary & Animal Sciences gate should also be restricted by the Security Personnel(s). In case of the entry of outsiders in the above gates with due permission of the University authority, proper entry of vehicle(s) and the person(s) with their contact number may be made in the registers maintained at the above gates. No reference, calls, messages should be entertained in this regard and the above instructions must be followed strictly. In case of any laxity personal responsibility of concerned security personnel/chowkidars will be fixed.

Further more, it has been noticed that employees of the different departments are not carrying the identity cards issued to them by the University Authority which would create inconvenience to implement the instructions. Therefore, it is enjoined upon all University employees to carry their Identity Card with them while entering the University. Also, there are outsourced/project staff of different projects and programmes in the various departments of the University and all of them should have a valid departmental Identity Proof with them to enter the University premises. Therefore, the concerned Heads of Departments may take note of the above instructions and ensure to issue Identity Proof to their outsourced workers/project staff.


All the Statutory Officers/ HODs/Units/Offices are requested to bring it to the notice of all persons working under their control for strict compliance.
