
NOTICE

It is for the information of all concerned that CSK H.P. Krishi Vishwavidyalaya, Palampur has decided to open Dr. G.C. Negi College of Veterinary & Animal Sciences of this University for the 4th year students of B.V.Sc. & A.H. programme to attend the clinical classes with immediate effect subject to the following:

1. The SOP on preventive measures to contain spread of COVID-19 in skill or entrepreneurship training institutions, higher educational institutions conducting doctoral courses and post graduate studies in technical & professional programs requiring laboratory/experimental work issued by the Ministry of Health & Family Welfare, Government of India dated 08.09.2020 and revised SOP on preventive measures to be followed while conducting examinations to contain spread of COVID-19 issued by the Ministry of Health & Family Welfare, Government of India dated 10.09.2020 will be followed strictly.
2. In case the number of students is more than the capacity of classrooms following physical distancing norms, then the Dean will permit attendance on alternative days or shifts as per local convenience. However, online studies will also continue.
3. The students will attend the clinical classes only with the written consent of their parents.
4. Attendance will not be enforced and will depend entirely on parental consent.
5. The Dean, Students' Welfare Officer, Head of Departments, Advisors and Wardens will get the SOPs followed strictly and visit the hostels frequently.
