
CIRCULAR

It has been observed that in various offices/Units/labs, the Energy Efficient heating appliances/devices/computers etc. are not being used in the University which is one of the reasons for increasing the consumption of electricity which also resulting heavy billing on account of power consumption in the University especially in the winter season. Apart from this, it has also been observed that during off hours the electrical appliances/devices/computers etc. which are not in use during off hours remains in 'On' position which is not a good practice.

In order to put this practice on rest, it is enjoined upon all that Energy Efficient Heating appliances be used and all such appliances be turned "Off" invariably while not in use during off-hours to minimize the excessive consumption of the electrical energy and also to curtail heavy billing amounts on the University exchequer. In case any such lapse is noticed in future, suitable departmental action will be taken against the erring employees. The officials put on watch & ward duty shall invariably check the appliances after 5:00 PM daily and report the lapse, if any, to the concerned Head of Department/Office/Unit. These instructions may be adhered to strictly in letter and spirit.


