
CIRCULAR

In view of the COVID-19 positive cases reported recently in respect of Dr. G.C. Negi College of Vety. & Animal Sciences, CSKHPKV, Palampur and decision taken in a meeting of Statutory Officers held on 07.03.2021 under the chairmanship of the Vice-Chancellor, the Vice-Chancellor has been pleased to order to modify the circular No. QSD.8-19/2020/CSK HPKV (GA)/13058-138 dated 06.03.2021 as under:-

1. Only the Statutory Officers **except Dean, Dr. G.C. Negi COVAS and Students' Welfare Officer** and invited female employees (Teaching and Non-teaching) of Palampur campus will now attend the University level Women Day function in the University Auditorium on 8th March, 2021 at 3:00 PM. **However, all the girl students and female employees (teaching & Non-teaching) of Dr. G.C. Negi COVAS will not attend the said function.**
2. All the Staff members (Teaching and Non-teaching), all girl students of College of Community Science and PG girl students of College of Agriculture and College of Basic Sciences will attend the aforesaid function as per circular dated 06.03.2021.
3. All Classes of the College of Community Science and PG classes of College of Agriculture and College of Basic Sciences will remain suspended on 08.03.2021 from 2:00 PM onwards to enable the girl students to attend the above function. However, the examination/viva of students, if any, of CoCS/CoA/CoBS fixed earlier will be held as per schedule. **The UG Classes of students of CoA/CoBS/CoVAS as well as PG Classes of CoVAS will continue as per time table.**
4. The Heads of Departments, girl students of CoA & CoBS and the invitees other than the above will not attend the aforesaid function.

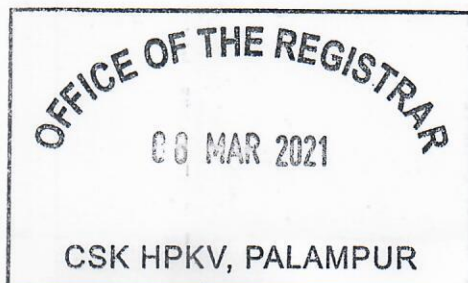
