OFFICE ORDER

26 MAR 2021

This is for information of all concerned that the Government of Himachal Pradesh has decided in a high level meeting presided over by the Hon'ble Chief Minister today on 26.03.2021 that all the educational institutions including Universities, Colleges, Technical Institutes and schools except for the classes having their examinations would remain closed with immediate effect upto **4th of April 2021** as a precautionary measure keeping in view the spike in covid-19 cases in the State.


In view of the above decision taken in the high level meeting, the Vice-Chancellor, CSK HPKV, Palampur has ordered to suspend classes (UG&PG) of all constituent Colleges of the University till 04.04.2021. However, any examination/Academic activity fixed earlier will take place as per schedule and online teaching/ classes would continue. All the teaching, non-teaching employees, project staff and other workers will continue to attend their duties as usual.

It has further been decided that if any student wishes to leave hostel he/she has to seek proper permission and will produce a negative RT-PCR test report not older than 72 hours at the time of his/her joining in the hostel. The students residing in the hostels will comply with all the SOPs issued by the State Govt. as well as University from time to time. All the concerned Hostel Wardens will be compliance officer to comply with all the SOPs issued in this regard.

No social and cultural events would be organized in the University and gathering would be restricted to maximum of 200 for indoor and 50 percent for outdoor events.

Further as per decision taken by the State Govt., **3rd April 2021** would also be holiday for all the offices in the University and there would be no public celebration of Holy.

All the Statutory Officers, Heads of the Departments/Units/Offices, Associate Directors/Scientist Incharges/Programme Coordinators are requested to bring it to the notice of all employees (teaching and non-teaching) and students working/studying under their control and ensure no deviation/departure from the same will be made by any functionary.


