In continuation of this office order No.QSD.8-8/2018/CSKHPKV (GA)/32838-937 dated 06.06.2021, the Vice-Chancellor has further been pleased to circulate the order No. Rev(DMC)(C) 20-2/2021-COVID-19-III dated 11.06.2021 (**copy enclosed**) issued by the Principal Secretary (Revenue), Government of Himachal Pradesh, Revenue Department -Disaster Management, Cell, Shimla regarding extension of "Corona Curfew" period till further order to contain spread of COVID-19 pandemic in the State/District, for implementation to the extent applicable in the University.

In view of the instructions referred to above, the Vice-Chancellor has further been pleased to suspend the UG & PG Classes of all the constituent Colleges of the University till further orders. However, Academic activities fixed earlier will take place as per schedule and online teaching/classes will continue as heretofore. Physical conduct of examination in the University shall be allowed on a case to case basis by the respective Deans with due intimation to the University authorities.

All should note that SoPs for social distancing and COVID safety protocols issued by the University, District administration, National Health Mission, HP and Govt. of H.P. from time to time be adhered to in letter and spirit.

The Associate Directors/ Scientist Incharges/Programme Coordinators, RRS/ RSSs/KVKs, will also adhere to the instructions issued in this behalf by the District Administration of concerned district.

All the Statutory Officers, Heads of the Departments/Units/Offices, Associate Directors/ Scientists Incharge/Programme Coordinators are requested to bring it to the notice of all employees (teaching and non-teaching) and students working/studying under their control including project staff and outsourced agency/service provider and ensure that no deviation/departure from the same is made by any functionary/ individual.
