

The candidates wishing to take admission through walk-in-interview will have to appear for the same on 24.01.2019 upto 11.00 A.M. in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur and shall have to mark their attendance in the attendance sheet/register kept there for the purpose, otherwise candidature will not be entertained and right to admission will be forfeited.
3. The admissions through Walk-in-Interview will be made as per provisions contained in Information Brochure & Prospectus Merit Based Admissions 2018-19 for B.Sc. Physical Sciences(Physics, Chemistry & Mathematics), B.Sc. Life Sciences (Botany, Zoology & Chemistry), B.Sc.(Hons.) Community Science, B.Tech.(Food Technology), B.Sc.(Hospitality & Hotel Administration) & Doctoral Programmes.
4. The candidates who had applied earlier for Doctoral programmes need not to apply again but have to appear for walk-in-interview. If any such candidate has not applied earlier under SFS category, he/she can apply for the same by depositing the requisite fee on the spot before 11.00 A.M. on the day of walk-in-interview. Further, if a candidate who had not earlier mentioned his/her category or failed to produce the desired certificate, he/she can also apply under the said category by producing the respective certificate.
5. All eligible candidates who did not apply for admission earlier can do so by applying with requisite fee on the spot latest by 11.00 A.M. on the day of walk-in-interview.
6. The candidate shall have to show all his/her original certificates/documents relating to admission to the Counselling Committee and also to submit a set of self attested copies thereof as listed in the Counseling Proforma alongwith Counseling Proforma (to be downloaded from the University website <http://hillagric.ac.in>) duly filled in all respects, at

- the time of walk-in-interview. The candidates who do not produce himself/herself with original certificates/testimonial at the time of counseling shall not be entertained.
7. The admission shall be made on the basis of merit list (As per mode of admission) to be drawn on the day of walk-in-interview.
 8. The Candidates appearing in walk-in-interview must have to bring a demand draft of requisite amount of fee except hostel charges drawn in favour of the Comptroller, CSKHPKV, Palampur and deposit the same on the spot in case they are offered a seat for admission.
 9. If a candidate fails to register himself/herself as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
 10. The vacancy position indicated above may vary at the time of Walk-in-Interview.


