

1. The quotation should be reach in the O/O the Comptroller, CSK HPKV, Palampur in sealed cover and super-scribed "quotation for purchase of Long Sling Bags with Logo of University on Flap" on 16-04-2021 by 5.00 PM. The quotation will be opened on 17-04-2021 at 11.00 AM in the presence of quote firms or their authorized representative, if present.
2. The rates should be quoted F.O.R. CSK HPKV, Palampur inclusive of all charges. GST extra, if any. (Nothing will be paid extra).
3. The quantity of materials can be increased or decreased.
4. The Comptroller also reserves the rights to consider or reject any of the quotations without assigning any reason.
5. The supply of the material is to be made by the supplier immediately.
6. The quotation received after due date will not be considered.
7. The condition of advance payment or through cash etc. will not be considered.
8. The quotation should be submitted only if the items can be supplied promptly on demand.
9. The price quoted should be strictly according to the specifications stated above.
10. The payment will be made after satisfactorily Inspection Report of the Inspection Committee so constituted for the purpose by the University.
11. Each quotation should be accompanied with a refundable earnest money @ 2%, if the total amount for the supply of the material exceeds Rs. 1.00 lakh in the shape of fixed deposit receipts/TDR/DD in favour of the Comptroller, CSK HPKV, Palampur. **Without EMD the quotations will not be considered.**
12. The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
13. Performance security will be obtained from successful bidder @ 5% of the awarded material.
14. GST No. may be mentioned in the quotation.
15. The conditional quotation will not be entertained.
