2. The quotations so received will be opened on 01.07.2021 at 11.00 a.m. in the office of the Comptroller, CSKHPKV, Palampur by the Committee so constituted for the purpose in the presence of tenderer or his representative who wish to be present.
3. The quotations may be submitted if the material is in stock and can be supplied promptly.
4. The delivery of the stores is to be effected immediately after confirmed supply order, otherwise the order will be cancelled or with at your risk, order will be placed with the next firm.
5. The Pad paper of the quotation should be signed with stamp of the firm.
6. The conditional quotation will not be entertained.
7. The quantity of Materials can be decreased or increased.
8. The conditions of advance payment or payment through cash etc. will not be considered.
9. The payment will be made after satisfactorily inspection report of the inspection Committee so constituted for the purpose by the University.
10. The University reserves the right to accept or reject the quotation without assigning any reason.
11. Being an Agricultural University the GST will be considered as 5% against GST exemption certificate.
12. The EMD of Rs.20,000.00 is required to be attached with the quotations.
13. The successful quotee will have to deposit performance security @ 5% of the total amount to be pledged in the name of Comptroller, CSKHPKV, Palampur.
14. The rate of GST should be @ 5% as per Govt. rule being a State Agricultural University against GST exemption certificate to be issued by the University.
